Comments:

Well done, Samuel, you have completed this project to a Satisfactory standard.

Context – Sam, your level of context is limited, you have explored some research around film music and production, but this lacks real detail and could explore the context of film music, songwriting and produced music in more depth and detail. The lack of research in this area, restricts your contextual awareness as it limits your presentation of you understanding of the context. You demonstrate some awareness through the music you have created but this is limited.

Research – You research is very limited and provides little understanding of the context or awareness of the main elements of composition and arranging. There is limited research on composing for film, composers, types of genres and sound design, music of themes. In Production you could have explored creating electronic music, why Ableton helps producers create live electronic music. In songwriting you could have compared different songwriters, styles and genres. It is also important to incorporate your research into your own work, you could have watched film composition videos on YouTube and explored some of the creative techniques or effects in your own work and then evaluated them.

Practical skills – The film for the Logic track is missing, it is very hard to grade film music with only the music available, please ensure you upload the finished work properly.

The composition for the track is good and it sounds appropriate to the film, in terms of its artistic merits. It's a shame to not be able to watch it in context of the film.

The Ableton track is excellent and demonstrates your ability to create immersive and creative productions. You could have added more instrumentation to fill out the song more, even as an atmospheric track you can add in more details to finalize the track more professionally, as there are some large spacious gaps where it feels a little lacking. The songwriting tracks would have benefited from more refinement and development.

Evaluation and reflection – There is evidence of some reflection and evaluation throughout the process of creation but this is limited and doesn't truly reflect on the decisions you made and more importantly why you made them. Your final evaluations are poor and do little to explain or reflect on the process of creating these three tracks. Comments like "I think I could've spent more time on the ending as it doesn't sound how I wanted it to sound" does not explain much in reflection, what did you want it to sound like? Why could you not achieve it? You need to spend far more time elaborating you on your research, context, planning and creative process.

Overall, Samuel, you have produced some great practical work, which would have been excellent if you had provided a video. But there is a lack of research and evaluation to meet the higher grades.
