Comments:

Well done Lukass, you have completed this project to a satisfactory standard. The work submitted meets all the assessment criteria and is of a satisfactory standard.

Composition for video game (assessor EH)

Well done Lukass, your composition is convincing and the overall sound design is good. More care with the melody would have possibly paid off maybe incorporating repetition as discussed or a particular focal point but you managed to build the piece well texturally. You show understanding in your working and your final composition shows wider awareness and relevant awareness of how video games are structured. But it would have been nice to see some of the examples we worked on both as a class and individually. Your piece shows sufficient planning, with a drawn out melody to start with and then you explain your experimental process, attempting to create a melody through trial and error then putting chords to it. Your piece is well structured and builds texturally really well, the chords fit the melody and the drums create tension and interest. I think the melody would have benefitted from being slightly more diatonic. Your evaluation was reflective and you talk about your preferences in regards to DAWs and your experiences using Logic X. It would have been good to see a little more reflection about how you feel the project went as a whole though and what you think the strengths/weaknesses were.

Electronically realised composition (assessor LB)

There is very little research on electronic composition and this is a shame as it doesn't provide any evidence of further research. Your planning is well documented, demonstrated the progress through the lessons and how you developed ideas and manipulated samples. The track has some good elements to it, the bass line however lets it down somewhat and doesn't really fit with the rest of the track. The beat, with you created with your own samples is good and works well with the funky guitar line. The guitar line is overused and could have been cut at some points or filter sweeped to keep the track interesting. The samples work well and illustrate your humor, which works well to create a unique track. The evaluation needs work, it explains what you did rather than the strengths and weaknesses of the project and also how you may approach things differently if you redid the project, this is and the research are key areas to develop.

Songwriting (assessor NS)

You successfully wrote and performed an original song after only 5 weeks to prepare. This is a good achievement and one you should be proud of! You really improved as a songwriter and guitarist throughout this project and undertook lots of extra practice – working well with Jozef and Kaitlyn to make sure you all had distinct roles. Your technique can still be refined but you have shown clear development in skill. There are some videos documenting the planning and rehearsal process and the final song. You set out your aims clearly in the intorudction and reflected on these in the project evaluation – well done, this is excellent and a process you should continue in Project 3. You have completed some ongoing evaluations of songwriting with some key details, but they could be more in depth at times. The research process must be more thorough to achieve a higher grade in future as there is very little research on display here. You could have also explained more details about your song and writing process – key, harmony, melody, scales, tempo, etc. You showed good professionalism and problem-solving skills working with your group and staying focused. You were a key member of the group for the writing and performance of your song. This is an enjoyable song and I look forward to hearing the recorded version! Well done!
