# **TRANQUIL** Licensing Agreement

## **1. Purpose of the Agreement**

## **2. Consent & Participation**

By The Licensor affixing their signature below, as the father and legal guardian of the associating minor, consents unreserved permission for the recording, editing, and employment of the student's image, voice, and activities in the documentary by Tranquil1.

Furthermore, Bradford College and Al-Mustafa Academy furnish consent to film on their premises and agree to being mentioned and represented visually in the documentary.

## **3. Ownership and Rights**

All footage, images, and audio captured during the project shall remain the intellectual property of Tranquil1. Tranquil1 pledges to abstain from distributing any footage that features the student on public social media platforms, including but not limited to Instagram, TikTok, YouTube, Facebook, and Twitter/X.

Nonetheless, the Producer may embody the final documentary into their personal academic portfolio, educational presentations, and submissions to recognised student opportunities and developmental programs as applicable.

## **4. No Compensation**

No financial compensation will be made available to any participants or institutions active in this production. Engagement is voluntary, and all parties relinquish any right to inspect or approve the final product.

## **5. Revocation**

At any time, this license may be revoked through written notification from The Licensor, Bradford College, or Al-Mustafa Academy. However, such revocation shall not apply retroactively to footage already captured and utilised within the permissible scope prior to the date of the revocation.

## **6. Entire Agreement**

This document constitutes the complete and binding agreement between all parties and supersedes all prior agreements or understandings, whether written or oral, pertaining to this project.

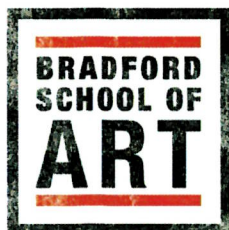
